Course Description: This course will inform the student of relevant matters in the creation or acquisition of a business. Specific legal theory covering personal and business planning, selection of the right entity, contractual matters, relying on professional advisors, creating employment agreements and contingency planning will be addressed.

Objectives:

1. Provide a study of the legal implications of the creation or acquisition of a business entity.
2. Examine basic issues related to entrepreneurial endeavors, including but not limited to contractual arrangements, employment agreements, entity selection and the taxation thereof, liability for the owner/operator and business termination.
3. The integration of said legal considerations into a business plan.

Competencies: The student who successfully completes this course will have obtained:

1. Specialized Knowledge. Entrepreneurship Law is a compendium of many different legal theories. A general knowledge of those theories will aid the student in action plans related to business startups or takeovers.

2. **Critical Thinking.** Understanding the theory of law and when and how to apply it requires analytical thought and reasoning abilities to achieve desired goals.
3. **Communication Skills.** Verbalizing the intent of a businessperson is critical in today's market. Oral and written skills will be addressed.

Double Enrollment: You may enroll in only one online course per semester unless you have received written permission from the Dean. If you are enrolled in more than one online course, you must contact the Registrar ASAP.

Grading: Your grade for this class will consist of a final exam and will be strongly affected by class participation which will take the form of participation in our Westlaw forum and homework assignments.

Readings: Required readings will come from your textbook. Recommended and supplemental readings will be available through our website. As these resources are primarily links to websites I do not maintain, if you should find that any of the links no longer functions, please contact me.

Technology Issues: All students are required to have an email account that allows you to send and receive attachments. You need to provide me with your email address by the first week of class (please see above for my email address). I will then provide you with access information for our class webpage. There you will be able to access updated syllabi, audio files of class lectures, and additional reference materials. Note: this course requires extensive use of the Internet. A background in the use of computer technology and the Internet is strongly encouraged. The technological requirements of accessing and using our website or the sites we link to are your responsibility as young professionals.
