Effective July 2018, Massachusetts began administering the Uniform Bar Examination consisting of 6 Multistate Essays, 2 Multistate Performance Tests, and 200 Multiple Choice Questions (Civil Procedure, Constitutional Law, Contracts, Criminal Law \& Procedure, Evidence, Property, and Torts)
