Faigle Bail to Jail

Bode Miller and Tyler Hamilton were lifelong friends who grew up together in the rough and tumble, ethnically diverse, neighborhood of Rocky River, located on the outskirts of Gotham City.

On Tyler's eighteenth birthday (Bode was exactly one month older than Tyler) the two were cruising the neighborhood in Bode's 1968 Pontiac GTO. Earlier that evening, Bode had purchased a twelve pack of Miller Light along with a gram of cocaine. He thought that they would share these in celebration of Tyler's birthday. As the evening wore on, the two did, in fact, consume five or six beers each. However, Tyler did not share Bode's enthusiasm for the cocaine and passed up any chance to partake. As midnight approached, both were feeling the affects of the alcohol, and in Bode's case the cocaine he had consumed. As they cruised down Main Street, they came to a stop at the intersection of Main and First. At the stoplight, a blue Porsche 911 came to a stop next to them. Both looked at the driver at the same time and, without saying anything to each other, knew him to be Pedro Martinez, a large scale marijuana dealer who, word had it, always kept a large amount of cash in his elegant, downtown townhouse.

The light turned red and the Porsche pulled away. Bode quickly floored the accelerator and the GTO's 389 cubic engine roared to life, easily keeping pace with the Porsche, but following at a discrete distance. Tyler, who was barely awake by this time, asked Bode why he was following the Porsche. Bode did not give him a straight answer. A short time passed during which neither spoke another word. Bode believed that Tyler was asleep and Tyler, although awake during the entire ride, let him continue to think that. Bode eventually brought the GTO to a stop in front of the house Tyler shared with his parents. Tyler, still playing possum, seemed to awake in a stupor. As he was exiting the vehicle he quickly glanced to his left at Bode and noticed a fairly large red stain on the front of Bode's shirt. Somewhat stunned, Tyler felt a sudden chill creep through his body. He began to tremble, afraid of what his friend had done. His mind began to race as he tried, in vain, to remember exactly what he to had done that night.

The next morning Tyler awoke with a mild hangover. His mother and father had already eaten breakfast and left the morning edition of the Daily Planet on the table. Tyler poured himself a large glass of water along with two Alka Seltzers. As he flipped the

paper open, he eyes were immediately drawn to the lead story. There, in bold headlines it proclaimed "ALLEGED MARIJUANA DEALER VICIOUSLY BEATEN AND EXPECTED TO REMAIN IN COMA".
