COVID-19 UPDATE: Bar Writing and Analysis for Fall 2020 will be in-person and on campus with limited online components. We will be following all MSL Community Agreement requirements, including but not limited to wearing face masks/face coverings/face shields at all times, practicing social distancing, following signs and directions regarding the flow of traffic in classrooms and hallways, and washing/sanitizing hands frequently. You will also be required to stay home if you have an elevated temperature or are feeling ill. If your absence is mandated by the MSL Community Agreement, we will make arrangements for you to make up any missed work.

In order to ensure the safety and well-being of our community, we will also be attempting to eliminate exposure and frequent contact through minimal exchange of paper and other documents. We will be following these steps for the entirety of the semester:

- 1. Other than in-class essays and exams, all graded assignments will be uploaded to TWEN and each student will be responsible for accessing, retrieving, and (if you so choose) printing the assignments from TWEN.
- 2. All assignments are due via email to be received prior to the start of class time on their due date. If you have been specifically instructed to handwrite an assignment, then you must do so but then scan (or take a photo) of the handwritten assignment and email to me before the start of class on the due date.
- 3. Unless you have received accommodations, all in-class essays, the midterm, and final exam will be submitted using Exam 4 software. You should make arrangements to download the software in the beginning of the semester rather than wait until the night before an exam. If you do not have a compatible device, you should consult with IT in order to determine how best to proceed. The schedule below indicates which days you will need to bring your device with you for in-class essays or exams.
- 4. I intend to hand you physical paper copies of in-class essays, the midterm, and the final so you can work with the paper and take notes, etc. I intend to handle

all paper while using gloves and maintain them in a folder until such time as it comes in your possession. Other than exams, if you prefer to receive digital handouts instead, you will need to bring your device to each class, as multiple handouts are provided in each class. If you have any concerns with this process, I urge you to contact me before the start of the semester so we can determine another manner or method of delivery.

- 5. I will not be meeting with students in my office this semester. If you have any concerns that you need me to address, kindly email me and we can schedule a phone or Zoom conference.
- 6. Regardless of your own personal opinions and/or beliefs about the measures taken due to COVID-19, I expect bar writing students to respectfully comply with all requirements of the MSL Community Agreement, MSL Student Handbook and Honor Code, CDC Guidelines, Governor Baker's Guidelines for Safe Reopening, and conduct yourselves in a manner befitting law students and future lawyers and community leaders.
- 7. If you have any objections to these requirements, I urge you to contact me or speak with Dean Kaldis (pota@mslaw.edu) prior to the start of the semester.

If, due to the public health emergency caused by COVID-19, MSLAW is required to shut down again during the Fall 2020 semester, Bar Writing will need to be conducted virtually through online platforms. In the event that the semester converts to virtual classes, in order to continue participating in the course, you will need to have access to the internet, an active TWEN account via MSLAW, ability to check your email regularly for course correspondence, access to a computer/laptop/smart device for in-class and home writing assignments, and a camera-enabled device in order to attend Zoom online classes. You may also need access to a printer.

| Course Description: | This course focuses on honing and improving students' analytical and writing skills, with a special emphasis on the analytical and writing skills used for successful completion of the essay portion of the bar examination. Students will explore issue spotting techniques and methods of analysis; learn helpful tips for writing essay exams; receive personalized feedback on essays; and review the substantive law necessary to write the essay portion of the uniform bar exam, as administered in Massachusetts. |
| Course Overview: | This is an intensive writing class, and you should expect to complete various in- class assignments, in addition to other exercises and scheduled readings. Students must have completed all seven substantive courses tested by the Multi-State Bar Exam before taking this course: Torts, Contracts, Property, Civil Procedure, Evidence, Constitutional Law, Criminal Law/Criminal Procedure. |
| | It is recommended that you also have completed Business Entities, UCC, Wills & Trusts, and Family Law. |
| | You will complete 9 graded in-class assignments during the semester, on which you will receive personal feedback. There will be 4 graded take-home assignments and weekly exercises. You will write a midterm exam and a three-hour final exam. |
| Course Grading: | Each assignment will be graded on a seven-point scale, consistent with the grading employed by the Massachusetts Board of Bar Examiners. |
