

SUMMER SCHOOL SCHEDULE - 2021

Registration for the first summer session will be Tuesday, **May 11, 2021** from 8 a.m. to 7 p.m.
Registration for the second summer session will be Tuesday, **June 15, 2021** from 8 a.m. to 7 p.m.

All students must receive the Covid-19 vaccine in order to attend classes at MSL this summer.

Anyone entering the building will need to have the Covid-19 vaccine and provide proof of that to the Registrar's Office. Classes are live in Andover with no remote alternative, although Remedies will be asynchronous and UCC in the evenings will be live through Zoom. First summer session examinations for UCC and Remedies will be administered through Examsoft.

Masks and social distancing are also required. If despite getting the vaccine, you are experiencing covid symptoms, then you must stay home. You also have the option of registering online by going to the Registrar's webpage and clicking on the link for summer registration.

STUDENTS PRESENTLY ON ACADEMIC PROBATION MAY NOT ATTEND SUMMER SCHOOL CLASSES.

Once again we will be asking students to email their request to reserve a place in a class with limited enrollment.

Starting Tuesday, May 4 for the first summer session, and Tuesday, June 8 for the second summer session, those students who wish to reserve a spot for a class with limited enrollment may, beginning at 8 a.m. in the morning, email the school (classregistration@mslaw.edu), the class they wish to register for. Please make sure the body of the email contains the class number, class title, your full name and your student ID.

In order to participate in the Clinic, you must have successfully completed Evidence.

A minimum of eight (8) people must register for a class in order for it to be offered.

If you have completed only one semester and you have completed *Contracts*, you may take only *UCC, Part I and Drafting Contracts* in the first session, and *UCC, Part 2, and Negotiating and Drafting Contracts and Agreements* in the second session.

If you are taking only one UCC course this summer, you will need to either take the other UCC course next summer or during the Fall semester. Both sections are necessary to complete your graduation requirements.

Your Faculty Advisor must approve and sign your course schedule (or send an email to the Registrar that your schedule is approved) before you register. Registration forms may be picked up from the Registrar's office and will also be available online. You may take two courses per session if you are not working full time during the summer. Courses may be dropped without academic penalty during the first week of a summer session.

You may choose to pay summer school tuition in installments. Payment is to be by check or in cash. **There are no federal loans for summer school tuition.** If you are attending during the first session, the first half of your tuition will be due at the time of registration (May 11) and the second half of your tuition will be due on June 15. No refunds are given once the class you are enrolled in has met.

If you will be attending the second session, the first installment will be due at the time of registration for the second session (June 15) and the second half will be due on July 15.

There is a \$50.00 late fee for registering after May 11 and/or June 15. There is \$100.00 late fee for registering once classes have begun.

If you will be registering for a friend, please keep in mind that you may register only one person who is registering for a class which has a limited enrollment. Thus, if you wish to register yourself for a class with a limited enrollment, you may not register anyone else for a class with a limited enrollment.

Any student who wishes to sign up for a limited enrollment class, it will be on a first-come, first serve basis on the day of registration.

ANY STUDENT WISHING TO TAKE COURSES AT EITHER NICHOLS COLLEGE OR FITCHBURG STATE UNIVERSITY MUST REGISTER WITH MSL FIRST. NO CREDIT WILL BE GIVEN FOR COURSES TAKEN AT EITHER OF THESE TWO INSTITUTIONS IF THE STUDENT HAS NOT REGISTERED WITH MSL FIRST. PAYMENT IS TO BE MADE DIRECTLY TO NICHOLS OR FITCHBURG, NOT TO MSL.
