## **AILALink Academic Adoption Information**

For law professors, assigning AlLALink as required or recommended course material is an affordable way to make multiple AlLA publications accessible to your students in one convenient place. You can learn more about AlLALink and view a list of the publications available by visiting <a href="https://www.aila.org/publications/ailalink">www.aila.org/publications/ailalink</a>.

If you are a professor and choose to assign AILALink as required or recommended course material, the students in your course will have two options for how they can gain access to AILALink.

- 1) The student can join AILA as a law student member. **This is the most cost-effective option for most law students** and allows them to access other AILA law student member benefits in addition to AILALink.
  - Law student membership is **free** for eligible law students. Information on the eligibility requirements for law student membership can be found at <a href="https://www.aila.org/membership/join/eligibility">https://www.aila.org/membership/join/eligibility</a>.
- 2) There may be students in your course who do not wish to join AILA as law student members, or, in rare instances, who may be ineligible to join AILA as law student members. These students can purchase AILALink at the academic adoption rate of \$75 for the duration of the course.

- 3) Direct your students to obtain AlLALink by either:

Students applying for AILA law student membership will need to upload a copy of their current official transcript. The AILALink subscription will begin immediately after the online application is submitted.
