The Massachusetts School of Law strives to ensure the success of each student. Law school is challenging and even the most successful students may need assistance adapting to a new academic discipline. Students may notice difficulty in absorbing new material, completing academic work, or understanding reading materials; anxiety about critical reading, writing, or test taking; and reluctance to speak in class. The office of Academic Support & Career Services provides our students with an opportunity to meet individually or collectively with a professor to consult about learning concerns. In addition, it provides students an opportunity to find support in mapping out their law school path to ensure success beyond the classroom.

There are many resources here at the law school to support you. From academic advisors, to student mentors, to a writing lab staffed with full-time faculty, and to specific sessions designed to support students in developing strong reading comprehension, writing skills, test-taking skills, and with time management and organization. In addition, there is support to help students navigate the law school curriculum by providing help with course selection with an eye towards ensuring success on the bar exam as well as positioning students for employment upon graduation. WRITING LAB

The MSLAW Writing Lab is a designated space that is located in the Demosthenes Writing Room (next to the offices of Professor Armano and Rodriguez in back of library). Any student may use the writing lab at any time to study. The lab is stocked with helpful writing aids and study aids.

Although writing classes are small, and students can ask for help from their instructors, MSLAW has recognized that this might not be enough for some students. There are designated hours when students can drop into the writing lab so that students can solicit extra help with particular writing problems they might have.

Students may receive help in any legal research and writing area from grammar to organization and types of legal authority, but they may not use the professors as copyeditors or proofreaders. The writing sessions may also be used as a way to solicit help with already submitted and graded work as a means of improving or understanding their weaknesses.

In addition to offering assistance to all students, the writing professors, in coordination with Assistant Dean Paula Kaldis, also participate in a mandatory academic assistance program for students on probation.
